ORDINANCE NO. 2015-16/3

ORDINANCE PROVIDING FOR THE LEVYING OF TAXES FOR THE LINCOLNWOOD PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2015 AND ENDING JUNE 30, 2016

BE IT ORDAINED by the Board of Trustees of the Lincolnwood Public Library District as follows:

Section 1: THAT the sum of TWO MILLION, FOUR HUNDRED AND NINETY-NINE THOUSAND DOLLARS [\$2,499,000]¹ as detailed in the following pages, is hereby levied upon all taxable property within the corporate limits of this Library District; and said tax is to be levied to defray the expenses and liabilities of this Library District for the fiscal year commencing July 1, 2015 and ending June 30, 2016.

Section 2: THAT said taxes are to be applied against appropriations heretofore made by ORDINANCE NO. 2015-16/2 adopted by this Board on September 17, 2015, which appropriations are also detailed in the following pages.

Section 3: THAT the Secretary of the Library District is hereby directed to file a certified copy of this *Ordinance Providing for the Levying of Taxes* with the Office of the Cook County Clerk within the time specified by law; and that said Secretary is further directed to post, and keep this Ordinance available, for public inspection by any interested party in the main office of the Lincolnwood Public Library District.

<u>Section 4</u>: THAT this Ordinance shall be in full force and effect from, and after, its passage and approval, as required by law.
